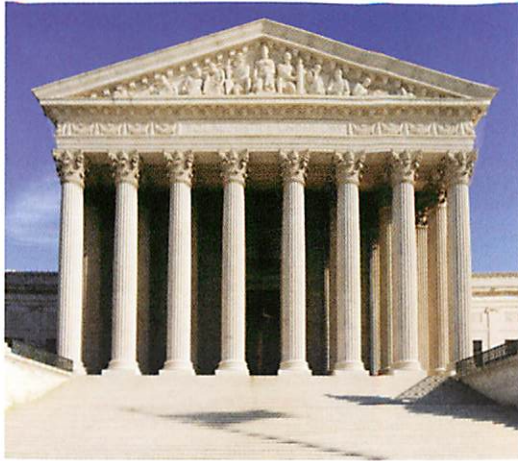

Why was my firearm purchase denied?

Federal or State Law Disqualification.

For most firearm purchases and transfers, Washington state law and federal laws now require a background check through the FBI Background Check System, or NICS.

NICS may deny your purchase for many reasons, including:

- Past Felony Convictions
- Involuntary Commitment to a Mental Health Facility
- Past Drug Use
- Domestic Violence Convictions
- Inaccurate or Incomplete Criminal History Information
